

Wayne County Junior Fair

2022 Royalty Application / Interview Process

Applications Due August 1st – Applicants must have completed at least 1 year on Jr. Fair Board. Applications distributed at June 13th Jr. Fair Board meeting and available online.

Applications reviewed by judges August 2nd – August 7th. Application will count for 25% of the score.

August 8th Junior Fair Board Meeting

- Up to 10 Court Members Announced at August 8th Junior Fair Board Meeting (If there are less than 5 male and 5 female applicants, any remaining spots will be nominated and voted on during this meeting)
- Court members will give one-minute speeches about why they would like to serve as King/Queen and on the Royal Court.
- Junior Fair Board will vote to give judges input on who should be King / Queen and Prince / Princess. The JFB vote will count for 25% of the score.

August 30th Coronation Interviews

- Members of the Royal Court will be interviewed by the judges on the evening of August 30th at the Extension Office. Interviews will count for 25% of the score.
- The judges will consider all four scores equally – application, junior fair board input vote, the interview, and hours of service / involvement in 4-H / FFA and Jr. Fair to make the final decision.

Scoring criteria:

25% Application / Essay Questions – Due August 1st

25% Hours of service / involvement in 4-H / FFA and Jr. Fair – Due August 1st

25% Junior Fair Board Input Vote – voting to occur on August 8th

25% Interview – Interviews to occur on August 30th

Announcement of King, Queen, Prince, and Princess will be made during the Coronation Ceremony at 8 pm on Saturday September 10th in the Event Center.
