# **Livestock News**

# Reminder about 2019 Quality Assurance Requirements

It is mandatory for all Junior Fair livestock exhibitors (4-H and FFA) to attend a quality assurance program before showing their animals at the Wayne County or Ohio State Junior Fair. Exhibitors of market steers, market dairy steers, market lambs, market goats, market hogs, all poultry meat pens, and meat rabbits, lactating dairy and lactating dairy goats will also need to complete a Drug Use Notification Form (DUNF) for each of these animals. The quality assurance requirement may only be met by participating in <u>ONE</u> of the following: (1) Quality Assurance program in Wayne County, or (2) An Ohio industry Quality Assurance training (e.g., Ohio Beef Expo, Ohio Pork Congress, etc.). *Online quality assurance programs are not acceptable per the current Ohio Department of Agriculture rules*.

Quality Assurance MUST be completed by **July 18th for the Wayne County Fair** or **June 9th for the state fair** participants (due to the ODA rule that members must complete QA 45 days prior to a show including State Fair). There will be one final QA Training on July 18 with a \$25 fee associated. If you completed Quality Assurance at a program outside of Wayne County, proof must be sent to the Extension Office by August 1<sup>st</sup>.

### **Animal Welfare**

Our youth exhibitors are considered producers and the public develops opinions based on what they see, hear and perceive at a livestock show and will relate that to the entire livestock industry. It is important all of our livestock exhibitors are responsible and represent it properly at all times. Remember to follow the 10 Good Production Practices (GPPs), reviewed during the Quality Assurance trainings to ensure proper care and handling of animals.

PLEASE discuss this during a club meeting. Having members role play or act out potential situations, which might occur at the State or Wayne County Fair, would better prepare our youth for answering questions they may get about their projects during fair week.

# **Upcoming Livestock / Animal Clinics**

#### **Poultry and Rabbit Clinics**

This year, we have planned one date for the clinic - June 22 @ 9 am at the fairgrounds. There will be both poultry and rabbit sessions going concurrently. Members may come and go anytime throughout the two-hour period but must stay the full time during QA to receive credit. The Clinic will be from 9-11 am and Quality Assurance will be from 11- 12. Also available at the clinics this year - tattooing for rabbits.

#### **Dairy Clinic**

This year's Dairy Clinic will be held **July 7<sup>th</sup> at 7 pm in the Coliseum.** QA will be offered.

### **Dog Obedience Clinic**

The next dog obedience clinic is June 25<sup>th</sup> at 7pm in the Sheep & Swine arena at the Wayne County Fairgrounds. QA will NOT be offered at this clinic.

#### **Meat Duck Orders**

Once again, 4-H and FFA members may order meat ducks from Centerra Co-op at a reduced Junior Fair Exhibitor rate! Exhibitors are responsible for making their own orders with Centerra Co-op at the Wooster location; they will NOT turn in orders to the Extension Office.

## **Skillathon / Livestock Interview Judging Requirements**

Information regarding Skillathon and Livestock Project Judging was mailed out to all organizational advisors, FFA teachers, and enrolled 4-H families. It can also be found at <a href="wayne.osu.edu/projectinfo.">wayne.osu.edu/projectinfo.</a> Please read through the letter and share at your club meetings.

Participation in skillathon or a livestock project interview is mandatory for all exhibitors (4-H and FFA) of livestock projects who wish to exhibit their animals at the Wayne County Junior Fair. The skillathon/project interview may be completed only in Wayne County or at the Ohio State Fair.

**Skillathon will be offered on July 9<sup>th</sup>, July 23<sup>rd</sup> and July 24<sup>th</sup>.** Members will need to attend <u>one</u> of these evenings to complete the skillathon/project interview for <u>each</u> species of animal he/she is exhibiting. The skillathons will consist of four stations that cover quality assurance issues and one station on project records (five total).

Members will have the option to sign up, for livestock project interview in place of skillathon. Livestock Interview Judging will take place during still project judging on July 15 and August 6. Members will have to register for a time slot for their interview and that will be available starting June 1st at <a href="http://go.osu.edu/2019interviews">http://go.osu.edu/2019interviews</a>. However, youth must complete skillathon to be considered in the Outstanding Market Exhibitor (OME), Outstanding Horse Exhibitor, and Outstanding Dairy Exhibitor (ODE) award programs.

It is mandatory that livestock exhibitors attend BOTH Quality Assurance AND Skillathon or Project Interview in order to exhibit at the Wayne County Fair!

# **Animal ID Reminder for Market Poultry and Market Rabbits**

Remember to submit your Animal ID information in 4-HOnline (oh.4honline.com) BEFORE attempting to make your Jr. Fair Class Entries (at waynejrfair.fairentry.com). Both Animal ID and Jr. Fair Class Entries are due August 1st but you must have Animal ID completed first in order to make your Jr. Fair Class Entries.

### **Market Rabbit Tatoo Dates/Times**

The Poultry and Rabbit Committee is offering an optional Market Rabbit Tatoo date on Saturday August 24<sup>th</sup> from 9-11 am in the old swine barn at the fairgrounds. This is a great opportunity to help speed up the check-in process for you and your family. All market rabbits not tattooed on August 24<sup>th</sup> will be tattooed at check-in on Friday September 6<sup>th</sup>.

### **Sheep Carcass Contest Update**

We want to say Thank You to Boliantz Packing of Ashland for agreeing to host our 2019 Sheep Carcass Contest! The live show will take place at the Wayne County Fairgrounds on Saturday August 24<sup>th</sup> and the Carcass Results Show will be at Boliantz's located at 749 Springmill Street in Mansfield on Thursday August 28<sup>th</sup>.

Important Details for the contest:

- Lambs must be tagged in at the June 1st Tag-in to be eligible to show in the carcass contest
- Carcass lamb must be entered on a Jr. Fair entry via waynejrfair.fairentry.com by August 1st (only one lamb may compete in Carcass Contest). Make Jr Fair entry in Department 24 Section 50 Class 3.
- Only the Champion & Reserve Champion carcasses will be sold at the Wayne County Fair live lamb sale on Wednesday September 11<sup>th</sup>. All other exhibitors must either find their own buyer or keep the meat.
- All meat will be processed by Boliantz to a set standard retail cut order.

# **Annual 4-H Back to School Supply Drive**

The 4-H Advisory Committee is again challenging your club to donate school supplies such as markers, compasses, colored pencils, erasers, notebooks, crayons, glue, tissues, hand sanitizer, etc. A grand prize will be awarded to the club with the most items donated per member in that club so that way all clubs have a fair chance of winning the 4-H Back to School Drive.

Once counted all supplies will be donated to the People to People Ministries for distribution to families in need.

### **Food and Nutrition Projects**

A common oversight for project judging is creating a meal plan for the entire day. As always you should prepare a dish/meal out of your book, additionally bring a poster or E-poster, your project book, a table setting (for the meal at which your dish is served) and a menu plan. The portion that is often overlooked is the creation of a complete menu plan for 1 day.

For example if you are taking the Star Spangled Foods project and bring the Wild West Burger to judging, you must then create a list of food you will eat for an entire day. Make sure to also follow the MyPlate criteria for serving sizes and categories to make a nutritious daily meal pan. ### E-Poster Requirements – option for all projects

If you plans to create an e-poster (computer based presentation) you must supply your own laptop or tablet. The presentation can be no longer than 15 slide advancements. And for the fair display you will then take a representation of your slides and make a 22"x28" poster to be displayed.

# Jr. Fair Class Entries - Due August 1st

Everyone planning to exhibit still, FCS, Livestock, and Cloverbud projects pretty much any type of 4-H or FFA projects at the fair must have them entered by 11:59 pm on August 1<sup>st</sup>. All fair entries must be submitted online in the fair entry system at <a href="https://waynejrfair.fairentry.com">https://waynejrfair.fairentry.com</a>. Please be sure to read and refer to the step by step instructions that were handed out with your copy of the Junior Fair Book. A copy of the instructions is available online at <a href="http://wayne.osu.edu/help">http://wayne.osu.edu/help</a>.

### **In-Person Fair Entry Help Sessions**

### When making your fair entries, please note:

- Members <u>must</u> enter their school code in their Jr. Fair online entry. This makes it possible for the Jr. Fair Secretary to send excused absence notices to the members' schools.
- Sheep and Goat project members <u>must</u> have entered the Scrapie number in the 4HOnline animal ID record which will be uploaded to the online fair entry.
- Members will fill out any special penning requests for their animals when making entries. Examples include: housing Jr. Fair animals with open class animals, market hogs that have been raised together and could be penned together, large rabbits that need extra pen space, etc.
- Make sure your members are aware that Showmanship entries MUST be made for <u>all species</u>:
   dairy, beef, sheep, swine, goats, rabbits, poultry, horses and dogs. If members do not sign up for
   their Showmanship classes in their online fair entry, they <u>will not</u> be able to show in the Showmanship
   classes at the Fair. Members wishing to compete in the Outstanding Exhibitor programs (i.e. OME and
   ODE) <u>must</u> make an entry for that class as well.

#### **PREMIUM PAYOUT**

The Junior Fair office will be doing ALL premium payouts after the Fair. Pre-check reports will be available on Friday, September 13<sup>th</sup> from 9:00 a.m. to noon. Checks will be distributed on Monday & Tuesday September 23<sup>rd</sup> and 24<sup>th</sup>.

# **NEW FOR 2019 – MARKET LIVESTOCK PHOTOS!**

All Junior Fair Market Livestock Exhibitors (except market rabbit and market poultry) should upload a photo of themselves with their Market Livestock Animal to be displayed during the Auction. This photo will come up on a screen while the youth is standing at the auction block next to the auctioneer. Market rabbit and market poultry photos will be taken at a designated time during the fair.

A list of tips / instructions for taking and uploading the photos was included with the Fair Entry instructions handed out with your Junior Fair Books. Please review that and be prepared to upload your photo when making your Fair Entries. ### **Ohio State Fair Information**

### Jr Livestock Exhibitors

To enter the 2019 Ohio State Fair Jr. Livestock Competitions, go to the website and download the Division Rules and Competition Information. Most State Fair Livestock Entries must now be made online. If not, you must also download, fill out, and have the entry forms signed and postmarked by JUNE 20<sup>th</sup>. You will then send this entry form to the Ohio State Fair Entry Department. The Livestock Rules and Information is available online at <a href="http://ohiostatefair.com/livestock">http://ohiostatefair.com/livestock</a>

There is also an online entry system available at <a href="http://ohlive.fairmanager.com/">http://ohlive.fairmanager.com/</a>, this MUST also be entered by June 20<sup>th</sup>.

### Signatures for State Fair Paper Entry Forms

Member must get a signature of the Extension Staff or Vo-Ag Educator before sending it to the state fair. 4-H entries must have a 4-H Staff member's signature and FFA entries must have their Vo-Ag Educators signature. (note very few State Fair Department's still have paper entry forms, most have gone on-line.)

### 4-H Handbook - Still and FCS State Fair Projects

The 4-H Handbook with non-livestock information is posted online. The handbook has 4-H exhibit information and State Fair Requirements that will be given to the 4-H member that is selected to go to State Fair in each class. ### **State Fair Dog Exhibitors**

Dog agility, dog show, and dog drill team entries sent to the state fair must be postmarked JUNE 20. Dog show poster contest sent to the Nationwide 4-H Center must be postmarked JULY 1.
